This is a commercial product whose exact ratio of components may vary. Minor quantities of other non hazardous ingredients are also possible. This product typically contains 80 g/L zinc, 145 g/L manganese and 10 g/L copper, however, the ratio and amounts of each varies as required. Hazards identified regarding this product relate to the maximum expected concentration for each hazardous ingredient, and may not necessarily apply if these ingredients are present at lower concentrations.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective chemically resistant clothing including eye/face protection, gauntlets and self contained breathing apparatus. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include no specific manufacturer recommendations. Use impermeable gloves with care. Eye/face protective equipment should comprise, as a minimum, protective glasses and, preferably, goggles.
